2010 – 2011 Tuition and Fees

Payment Schedule for New Students

Prekindergarten through Grade 5.....\$13,900.00
Grade 6 through Grade 8\$14,660.00
Grade 9 through Grade 12\$17,500.00

A \$1,500.00 initial payment is required when the Enrollment Agreement is submitted. Included in this initial payment is the one-time Enrollment Fee of \$500.00 which serves to hold a place for the student. The Enrollment Fee and tuition payment are non-refundable as stated in the enrollment contract.

TUITION MAY BE PAID USING ONE OF THE TWO FOLLOWING OPTIONS:

PLAN A includes a \$200 discount for Prekindergarten through Grade 5; and a \$300 discount for Grades 6 to 12. Additionally, the monthly service fees totaling \$240.00 per year are saved. **The early payment discount is available through June 1, 2010; if payments are not received by this date, the discount is forfeited.** After that time, payment in full will save the cost of monthly service fees. **Tuition insurance is optional, however strongly encouraged.**

PLAN B is a twelve (12) month plan with payments due on or before the 1st day of each month beginning with the first such payment due on or before May 1, 2010. Students enrolled after May 1, 2010 will be billed in equal monthly installments from the date the contract is signed through April 1, 2011. Payments reflect a \$20.00 monthly service fee per child. Payments also include pro-rated fees (see the Annual Fee section below). Tuition Insurance is billed in full on the July statement (see the Tuition Insurance section below). Parents may elect to have payments automatically deducted from bank accounts.

TUITION INSURANCE: Coverage is required for all Plan B participants and is optional, however strongly encouraged, for Plan A. The rate is 1.62% of the total tuition. If selected for Plan A, Tuition Insurance will be billed in June; for Plan B, the Tuition Insurance will be billed in full on the July statement. The rates are as follows: PreK – Grade 5: \$225.18; Grades 6 to 8: \$237.49; Grades 9 to 12: \$283.50.

ANNUAL FEES: \$1,300 PER STUDENT

Supply and Technology Fees: Supply Fees are \$350.00 per student and cover EF supplies, the majority of field trips, a yearbook for each student, and incidentals throughout the year. The Technology Fee is \$350.00 per student.

Facilities Fee: \$600.00 per student. The Facility Fee is a fee to address the continued costs associated with the campus.

SENIOR FEE: \$500 PER GRADE 12 STUDENT

Students in Grade 12 are charged this additional fee to offset the costs associated with college applications and graduation. This fee will be billed with the other annual fees in June for Plan A and in the July statement for Plan B.

FINANCIAL AID: Applications are available through the Business Office or online using the SSS link from the www.nais.org website. (If you file online, please be certain to read the letter under the Financial Aid Philosophy tab in the Admission section at www.seacrest.org. This letter has additional information for applying for financial aid.) If financial aid needs are not met, the initial payments and Enrollment Fee will be refunded. No financial aid applications can be accepted without an Enrollment Fee. Please note that financial aid applicants are not eligible for the Plan A discount.

TEXTBOOKS: In Prekindergarten through Grade 8, textbooks are provided to the students. High School students purchase their textbooks online through www.mbsDirect.net.

BEFORE AND AFTER SCHOOL PROGRAMS: These programs are open to all Seacrest students. Before School care is available starting at 7:15 AM; there is no charge for Before School care. The After School Program is available every day from dismissal time until 5:30 PM. Two pricing plans are available.

1. Children may be enrolled for the entire year for an annual fee of \$1,500.00 (approximately \$8.75 per day).
2. Children using the program on an as-needed basis pay a maximum daily rate of \$12.00 computed as follows:
from 2:30 to 4:00 (or any part) the cost is \$6.00; from 4:00 to 5:30 (or any part) the cost is \$6.00.

Younger siblings and car pool riders waiting for older students to be dismissed at other car lines are not charged.

BUS SERVICE: The school has a bus route that begins at Bonita Beach Road and US 41 each morning. Stops are made at Immokalee Road, the library at Orange Blossom, Orchid Drive at Mandarin Road, and Cambier Park. There is no afternoon bus service. This bus is equipped with both seat belts and air conditioning. Students may ride occasionally and pay a daily “drop-in” rate or sign up to ride for the year at a discounted rate.
